THE HOLIDAY CENTER RULES

The Resort Naturista GROTTAMIRANDA is a private residential naturist area, owned by SCI Puglia Immo and administered by Sogno di Puglia srl and dedicated to open-air tourism and leisure employed a residence with no other use and respecting the following principles:

- Encourage the practice of healthy family and natural nakedness.
- Guarantee the best welcoming to every naturist guest in the respect of everyone.
- Assure tranquillity by organizing sport and cultural activities for those who are interested in.
- Ensure guests' security and respect of naturist ethics without accepting within the area any attitude to voyeurism that may shock children or adults.
- Inform guests about the possibility to practice naturism throughout the year, making them acknowledged with national as well as international accommodations: clubs, associations, federations.
- Respect and preserve nature, protect environment favouring energy saving as well as water saving.

1. Conditions for Admission

The Area Administration is defined as supreme authority enabled for administration by Sogno di Puglia srl.

- 1.1. Enter and stay at the **Resort Naturista GROTTAMIRANDA** implies the acceptance of this dispositions contained in the present regulation act and the commitment to comply with it. Any violation to the present regulation act may result in the expulsion of the responsible guest with recourse to law enforcement if necessary.
- 1.2. The Village Administration will have the necessary means to make guests comply with it. The Village Administration may impede admission for those who refuse to comply with this internal regulation as well as with the Naturist Charter attached.
- 1.3. Unaccompanied minors by parents or guardian must submit a parental legal authorization (police department). Their guardianship shall be on the guardian. In the event they remain alone in the Centre, without parental authorization, they might be brought back to the main residence by a person in charge of **the Resort Naturista GROTTAMIRANDA** and incurred expenses must be borne by the guardian.

2. Stay Conditions

2.1 Operational Rules

To stay at **the Resort Naturista GROTTAMIRANDA** the following requirements have to be fulfilled:

2.1.1. Have fulfilled with the charges. Be covered by third-party liability insurance.

2.1.2 All expelled guests' assets which are not withdrawn within the period of one year and a day starting from the expulsion date, are acquired by the Centre, without any warning and without any appeal whatsoever, as well as all the items left behind and unclaimed at the same term.

2.2. Residential Regulations

Only few secondary homes are authorized. Anyway, exceptionally and temporarily some derogations may be admitted. They will be examined by the Centre Administration.

3. The Village Opening

The centre is opened from April 1st to November 5th of every year. Reception is guaranteed in the opening times annually fixed by the Administration. Outdoor parking is open night and day.

Guests who arrive at the Centre outside the fixed opening hours, must inform the Centre reception in order to organize their welcoming.

4. Clothing

Nakedness is the rule within the limits of **the Resort Naturista GROTTAMIRANDA**. It is compulsory in the swimming-pool or by the pool where no derogation can be admitted.

The Resort Naturista GROTTAMIRANDA's staff is entrusted with enforcing the naturist spirit as defined in the introduction to the present regulation act. Nakedness is the rigour as long as weather conditions allow it.

5. Hygiene, physical appearance and facilities

- 5.1. Centre admission is forbidden or exclusion pronounced to those who does not present in his/her physical appearance minimal standards of cleanliness.
- 5.2. Everyone shall refrain from any act that may affect cleanliness and the Centre appearance. Hygiene rules must always be observed according to the Administration regulations.
- 5.3. Each guest is personally responsible with third-parties for interference to the centre fruition, for any violation to the present regulation act and for the consequences which he/she, his/her family, his/her guests may originate.

- 5.4. Each guest will employ the material made available to him/her according to its use and refrain from provoking degradation of any kind. In the sewers do not have to be thrown away any foreign matter which is likely to block them.
- 5.5. The trash as well as offal of any kind, the papers must be deposited into the dumpsters after having been enclosed in plastic bags. Used glasses must be deposited in the appropriate containers arranged for this use, excluding any other place. It shall be prohibited to destroy the trash through fire or by any other means.
- 5.6. The clotheshorse can be used on the terraces by employing the provided one. It cannot be used out of the terraces or between the trees.
- 5.7. Guests shall not introduce or maintain dangerous, unhealthy and foul smelling material. Storage of hydrocarbons and of other unstable or flammable products in the apartments strictly prohibited.
- 5.8. Plants and flower arrangements shall be respected. It shall be prohibited to damage environment in any way.
- 5.9. Guests are not allowed to ring-fence an area by their own means or modify the features of the ground. Every defacement committed against vegetation, fences, ground and facilities of **the Resort Naturista GROTTAMIRANDA** is to be borne by those responsible.

6. Movement and car-parking

- 6.1. To park outside the delimited areas or outside the indicated parking-areas it is not allowed. In the event of repeated infraction, the offender's admission to the Centre shall be prohibited by the Administration.
- 6.2. No vehicle under repair shall be parked. For safe-keeping, the guests who are in possession of a car whose engine presents leakage of inflammable substance (such as gasoline, oils and grease) shall wipe crud off or clean the polluted areas. To permanently park boats or other engines it is prohibited.

7. Noise pollution

The Resort Naturista GROTTAMIRANDA's guests are required to avoid noise or discussions which may disturb the neighbourhood. Musical instruments as well as radio-television sets are not accepted provided that they are inaudible to the neighbourhood. Noisy home appliances and for bricolage (vacuum cleaners, sanders) are subjected to the same regulation. The closing of doors and of boxes should be as discrete as possible, as well.

Quietness and calm shall be assured and respected between 11 p.m. and 7 a.m. and from midnight to 8 a.m. on holiday and over the week-end.

8. Animals

Despite our love for animals, they are not allowed at **the Resort Naturista GROTTAMIRANDA**.

9. Pictures and films

Taking photographs and filming a person or a group of people is strictly forbidden without permission. Contravention of this article, shall render the offender liable to instant removal and to the delivery of the video contained in the camera. Pictures shall be destroyed at the owner's presence and delivered against receipt to the complainant who may use it freely without prejudice to proceedings that may be undertaken.

10. Statements and attitudes

- 10.1. 10.1 Pasting on advertising hoardings is subjected to the Administration prior authorization or to one of its representatives. Impromptu pasting is not allowed.
- 10.2. 10.2. Public meetings on political, racial or religious subjects are not allowed. Every manifestation, conference, artistic or sport contest, cannot be organized without the Administration authorization.
- 10.3. 10.3. Collections of money, requests, games of chance are not allowed.
- 10.4. 10.4. Every event, move or attitude contrary to the accepted principles of morality leads the offender to instant removal without prejudice to legal proceedings that may be undertaken.
- 10.5. 10.5. People under the influence of alcohol who arouse scandal disturbing **the Resort Naturista GROTTAMIRANDA**'s quietness shall be expelled by the Administration.
- 10.6. 10.6. Utmost politeness in guests' relationships or with local non naturist residents in the vicinity of **the Resort Naturista GROTTAMIRANDA**, is recommended.

11. Leisure

Close to the installations no violent or embarrassing game is allowed. Leisure-areas and social rooms are available to guests in accordance with the requirements of its own specific regulation act. Walks in green areas are open to each guest.

12. Responsibility

Please inform The **GROTTAMIRANDA Naturist Centre's** Administration of the presence of any suspect. Every violation committed on vegetation, materials and installations as well, shall be borne by his/her author. Each guest is responsible to others for the dangerous consequences aroused by his/her fault or negligence or by his/her family, guests, partners as well as by fault committed by a pet or assets that he/she is responsible for.

The Village Administration assumes no responsibility for thieves, crashes, casualties, etc that guests may be victim of all over the area of **the Resort Naturista GROTTAMIRANDA**.

13. Camping – Caravanning

Camping, caravanning as well as camping-car strictly not allowed within the area of **the Resort Naturista GROTTAMIRANDA**

14. Security – Fire

- 14.1. Since environment is particularly sensitive and fire risks elevated, there will be permanent surveillance.
- 14.2. Fire of wood and of any other origin particularly barbecues strictly not allowed except for the barbecues which are made available to guests.
- 14.3. Fire extinguishers as well as fire- fighting equipment is made available to everyone.
- 14.4. in the event of casualties, each guest has to inform **the Resort Naturista GROTTAMIRANDA** Administration immediately making himself/herself available.
- 14.5. To open electrical switchboards is not allowed.
- 14.6. To guarantee surveillance, **the Resort Naturista GROTTAMIRANDA's** guests have to take every precaution for the storage of their material.
- 14.7. Equally, guests shall comply with every administrative arrest, hygiene rule and healthy condition as well as any other city or police regulations.

15. The Resort Naturista GROTTAMIRANDA Administration's Powers.

The Village administration is responsible for order, good maintenance as well as compliance to the following regulations. It has the power to sanction severe violation to this regulation act and to expel the offenders if necessary. Only properly dated and signed complains complete with name and address shall be taken into consideration They have to be as precise as possible and be concerned with recent events.

As this regulation act is written with the aim of ensuring the quietness and safety of everyone, of preserving the naturist spirit as well as our Resort Naturista GROTTAMIRANDA's area, we should be grateful if you would comply with it ensuring it is honoured by kindly intervening with those who seem to ignore it.
